 - During the next portion of the meeting, the election ballot was sent out at approximately 1:10 to all neighbors attending the meeting with voting starting at 1:10 p.m. and requested to complete by 2:00 p.m.
 - Open topics for discussion Patty F.
 - Good reminders and historical info for new neighbors:
 - Fences, pools (fence not permitted unless around the perimeter of the neighborhood and no above-grounds; only in-ground)
 - The McGills advised they are having an in-ground pool installed with fence around the top of it
 - Jeff reminded all that in order to change the covenants, which govern our bylaws around these items, 75% of neighborhood agreement is needed. This was put into practice many years ago re: fences and was voted down.
 - Neighbor concerns:
 - Various makes and models of cars taking random pictures of our homes in general and some of vehicles extending over the sidewalk on the driveway (this item was new to the HOA and other neighbors)
 - It was noted that one car that was at the prior Kay home near the entrance was taking pictures of the long view of the sidewalk while kids were out playing
 - Action: Lorelei will take the opportunity to call the local police to let them know of different cars taking pictures of our homes and pictures of parked cars. Recommendation from the PD is for neighbors to always call in if there is an issue that needs their attention – the non-911 # - unless it is truly an emergency.
 - Our neighbor at the front entrance brought it to the board's attention there is an increased amount of turnarounds in their driveway to go north on Haegers Bend. The HOA has no jurisdiction in this area but will respond to the homeowner to bring it to the attention of the Barrington Hills PD to see if anything can be done.
 - Ding-dong ditches seem to be happening to a few neighbors
 - Cars speeding in the subdivision please use caution

- Pet waste unchecked not picked up; this is always a common courtesy and always a reminder in the Newsletters
- There was interest in future block parties (as soon as COVID is over!) as Andre can provide the music as he DJs and Mark K. has agreed to cook! We will be looking for one or more of our neighbors to head up that committee when the time comes.
- Good reminder that as neighbors, please work together with respect and courtesy if there is a concern between one another
- Discussed the resumption of neighborhood watch
 - This was a good discussion differing viewpoints on the need
 - It was agreed that all neighbors should be able to watch out for one another and be good neighbors
 - We may look into re-engaging the local PD with a formal neighborhood watch program; Patty Fasano has volunteered to lead that effort.
