2022/2023 Budget Review (Attached)

- Screen share portion of 2022 expenses and proposal for 2022/2023 \$11,700 available cash on hand; \$3,000 for fence repairs/replacement & \$5000 for tree line replacements
- Dues Planned Upon Approval from new Board \$150.00 flat from 2021-2022

Open Session for Discussion Topics

- **Speeding:** Neighbors expressed concern for speeding down Buckthorn Drive. If you live on Buckthorn (or anywhere else for that matter), please be mindful of your speed there are children and pets enjoying the weather
 - The discussion centered around installing a temporary speed radar sign at a key location to create awareness for all of us just how fast 30 mph is on our side streets ... feedback from those that back up to Haegers Bend is that the Barrington Hills speed radar sign seems to be sending the message to vehicles that travel that route. The team will determine where the sign is best suited for optimal visibility – it will be on a parkway.
- **Feeding feral animals:** Neighbors asked if there was anything the Board could do about neighbors feeding wild animals
 - After talking with your neighbor with no resolution, concerns about feeding wild animals should be directed to the Village of Algonquin to investigate if there is an ordinance against doing so. If a neighbor approaches another neighbor for doing so, please be respectful and neighborly and listen to the concerns of your neighbors.
